Inter exams from April 8, SSC May 2

9,86,533 to appear for Inter theory exams at 1,456 centres, practicals to begin next month

WHILE the Class 10 SSC exams will take place from May 2 to 13, the Intermediate exams (for both years) have been scheduled to be held between April 8 and 28 in the State. Ministers Audimulapu Suresh and Buggana Rajendranath Reddy on Thursday released the schedule for both the examinations, in Kurnool. The school and Inter exams will be held from 9.30 am to 12.45 pm and 9 am to 12 pm, respectively, as per the time table. Inter practical tests will take

place from March 11 to 31, said the education minister, who had earlier clarified that it was necessary for all students to take the exams.

It may be recalled that the State government had cancelled the examinations of the last two years, and passed all students due to the pandemic.

Addressing the media, Suresh said there is no threat

to the health of the students as the government is taking all Covid precautionary measures at schools and colleges.

He said a total of 9,86,533 students will take the Intermediate theory exams at 1,456 test centres across the State; 3,34,815 will appear for the practical exams to be held from March 11 to 31 at 1,757 centers. Tests on Ethics and Human Values will be

held on March 7 and Environment Studies on March 9, he informed.

"The exams will be held amid strict Covid-19 protocols. The decision to hold the exams was taken only to benefit the students' academics. The exams' schedule will not collide with any competitive exam."

Suresh also ordered the department officials to ensure sanitation at all exam centres and set up thermal screening units there. Students will be allowed to the exam hall only after thermal screening and if they wear proper face masks.

The exams will be held amid strict Covid-19 protocols. The decision to hold the exams was taken only to benefit the students' academics. The exams' schedule will not collide with any competitive exams

Death of tigress: Two forest officials suspended

TWO forest staff have been placed under suspension for their alleged negligence in tracking wild animals in their jurisdiction.

A tigress, aged around 3, was found dead under suspicious circumstances near Gandaleru reservoir under Chelama forest range of Nandyal division in the Nagarjunasagar Srisaillam Tiger Reserve (NTSR) on Wednesday.

Official sources said the news of the tigress death in the forest was circulated on social media platforms three days before the forest staff found its carcass. It was only through locals that the forest staff came to know about the tigress death.

Taking serious view of the lapse of staff, Conservator of Forests P Rama Krishna on Thursday issued an order suspending Peddakambalur forest section officer Srinivasa Reddy and forest beat officer



James Paul for their negligence as the duo were supposed to keep a track on the wild animals in their jurisdiction.

Meanwhile, the forest officials are yet to get the post-mortem report to ascertain the cause of tigress death.

It is suspected that those who were behind the death of tigress, might have tried to erase evidence as burn marks were found on its body, sources added.

ANDHRA Pradesh reported 1,345 fresh cases of Covid-19 in the 24 hours ending 9 am on Thursday. The latest bulletin said 6,576 infected persons got cured while four more succumbed in the State.

The State has tested a total of 3.27 crore samples, including 26,000 afresh.

East Godavari registered the highest single-day spike of 309 infections even as all other districts reported a daily growth of below 200 in their caseload. The lowest of 16 positives were reported in Vizianagaram.

With the fresh spike in cases, the overall infections in Guntur went past 2.02 lakh, while Kurnool and Nellore's cumulative tally crossed 1.44 lakh and 1.64 lakh, respectively.

The fresh recoveries took the



overall to 22.54 lakh and brought down the caseload to less than 41,000. Prakasam district has the highest 13,640 active cases while the lowest figures of 398 were in Vizianagaram.

One each death was reported from Chittoor, Krishna, Kurnool and Nellore.

Minister calls on Gadkari

Vijayawada: State R&B Minister M Sankara Narayana met Union Transport Minister Nitin Gadkari in New Delhi and invited him to Vijayawada to lay the foundation for 51 projects, worth ₹20,000 crore, on Feb 17. Speaking to media persons in New Delhi, he said he has requested the Centre to grant funds for Vijayawada East Bypass and a six-lane Visakhapatnam-Bhogapuram road.

Leopard killed on road

Kadapa: A year-old leopard was killed after allegedly being hit by a vehicle on Rayachoti Road at Guvvalacheruvu on Wednesday. The leopard was suspected to be crossing the road from Seshachalam forest when the mishap took place. Upon being alerted by locals, forest officials reached the spot and shifted the carcass of the leopard to Rayachoti forest office.

Toddler reunited with parents

Ongole: Prakasam police found a kidnapped toddler and reunited him with his parents within seven hours of receiving a complaint. Three persons, including two women, were arrested in the case, police said on Thursday. The nine-month-old's mother on Wednesday complained to the police that her son had gone missing. SP Mallika Garg formed a special investigation team to find the baby.

15 kids at Anganwadi suffer 'food poisoning'

AT least 15 children fell sick after they reportedly ate adulterated food at an Anganwadi in Podaluru town of Nellore district. According to reports, the children were suffering from diarrhoea since Wednesday evening.

Parents staged a demonstration at the Anganwadi and blamed the negligent attitude of the staff for delaying treatment to their children. They alleged that the children began vomiting and fell sick after eating food provided at the Anganwadi. They said the children were admitted to a local hospital for treatment where doctors confirmed that they fell sick due to the adulterated food they ate.

The children are getting treated at various hospitals in Podaluru and Nellore city. Sources said their condition is stable now.

ICDS supervisors Shakuntala, Bhagya Lakshmi, and Mahila Police Vijayalakshmi inspected the Anganwadi centre on Thursday and spoke to Anganwadi volunteer Amaravati and domestic help Rameeza to enquire about the incident.

GOING CASHLESS

Now, pay for unreserved train tickets through UPI

IN a move to encourage cashless transactions and digital payments, the South Central Railway (SCR) has introduced payments for tickets at automatic ticket vending machines through QR (Quick Response) codes.

In a press release on Thursday, SCR general manager Sanjeev Kishore said in addition to the existing modes of payment, passengers will get the option of making UPI payments through PayTm or Freecharge. The ATMs will display the QR codes, which can be scanned for buying the tickets.

After successful transactions, the machines will generate automated unreserved and platform tickets. Till now, the passengers had to buy smart cards mandatorily

and recharge it with money in order to buy from the ATMs. The smart cards can be recharged online or at general booking counters

In order to extend this facility to the rail users who do not have smart cards and to further encourage the digital payments duly simplifying the process, a user-friendly system of payment has been introduced for purchase of tickets by utilising the payment gateways (Paytm or Freecharge), duly scanning the QR code which is displayed on ATMs, the release said.

"We appeal to all rail users to utilize the service to buy the general tickets and avoid queues and cash transactions at booking counters. This facility will immensely help the rail users to have safe and secure travel during the pandemic," the SCR GM added.
